



Step 2: Produce Battery-grade Materials from Black Mass

Unique high-performance hydrometallurgy process:

- √ 95% to 98% of all valued materials recovered (Li, Ni, Co, Mn, and Graphite)
- ✓ Li, Ni, Co of purity in battery-grade range
- ✓ Includes recirculation of process streams to optimize efficiency and minimize operational costs and environmental impact.
- Follow best industrial safety practices
- Replicable processes
- Designing our own commercial hydromet plant. Expected start of operation: 2028
- ➤ Technology offered to partners as the Lithion Hydrometallurgy Technology Package (LHTP)






